#### WHAT IS THE TOURISM ASSESSMENT PROGRAM?

The California Tourism Marketing Act of 1995 enabled the state's tourism industry to assess itself to conduct statewide marketing. In 1998, the industry voted to pass the first industrywide referendum, creating the Tourism Assessment Program and establishing the California Travel and Tourism Commission as the first-of-its-kind destination marketing organization in the nation.

The Tourism Assessment Program is a self-assessment. A business receiving a notice to file the Tourism Assessment Form has been identified as a potentially assessable business falling into one of the travel and tourism industry categories as identified in the California Tourism Marketing Act, Government Code 13995.

## TRAVEL & TOURISM INDUSTRY ASSESSMENT CATEGORIES & ASSESSMENT RATES:

- Accommodations: \$1,950 per \$1 million in travel-and-tourism-related revenue (multiply 0.00195 by assessed dollar figure).
- Attractions & Recreation: \$975 per \$1 million in travel-and-tourism-related revenue (multiply 0.000975 by assessed dollar figure).
- Restaurant & Retail: \$975 per \$1 million in travel-and-tourismrelated revenue (multiply 0.000975 by assessed dollar figure).
- Transportation & Travel Services: \$975 per \$1 million in traveland-tourism-related revenue (multiply 0.000975 by assessed dollar figure).
- Passenger Car Rental: 3.5% of monthly revenue.

### FILING AND PAYMENT DETAILS

## WHAT IS NEEDED TO CALCUATE THE TOURISM ASSESSMENT FEE?

To complete the filing, you will need gross revenue from the most recently completed tax year and the percentage of that revenue that came from travel and tourism for each physical business address.

#### HOW DO I SUBMIT THE TOURISM ASSESSMENT FORM?

### **HOW DO I PAY THE TOURISM ASSESSMENT FEE?**

## HOW IS PERCENTAGE OF TRAVEL AND TOURISM DETERMINED?

As business within the **accommodations industry** category, revenue derived from any charges in conjunction with an overnight stay is considered travel and tourism revenue. Revenue from 31 continuous day stays or longer by the same individual is not assessable. Examples of assessable revenue include, but are not limited to, business and leisure travel, government travel and corporate contracts.

As a business within the attractions and recreation, transportation and travel services, or restaurant and retail industry categories, revenue derived from any individual or group of persons who travel 50 miles or more to your business location is considered travel and tourism revenue. The business location and proximity to major freeways, attractions, outlet/premium shopping malls, lodging, or destination locations and venues should be considered when determining the percentage of revenue earned from travel and tourism. In addition, the business' credit card data, market research, consumer surveys or analysis can provide information to assist in determining percentage of tourism.

# MY BUSINESS IS EXEMPT. DO I STILL NEED TO FILE A FORM?

Yes, in any year that your business is noticed you must file a Tourism Assessment Form. The Office of Tourism may not be able to determine that your business is exempt without the information provided on the Tourism Assessment Form.
